10. Topical Meeting Business:

PSA 2019

- Hotel was visited by committee in January and found to be acceptable
- Committee will have its next teleconference on 2/23/2018
- Call for papers is to be issued within the next 3 weeks

NETS 2020

- NETS will be February 2020, expect ~150 attendees
- Topical has been proposed for 2020
- Jeff Brault led the bid on behalf of the section and NETS executive committee has accepted.
- Jeff called for a vote to support the NETS 2020 meeting and it carried.
- Local EC will need to fill required positions
- Have proposed to use the typical Marriott in Charleston but with a smaller conference, a smaller venue may be in order
 - o This issue was tabled for now.
- NETS will need the usual local section staffing requirements met

TOFE 2020

- TOFE will be April 2020, expected ~300 attendees (similar to Tritium topical)
- Option to host this meeting came through Tinh about the same time as NETS 2020.
- TOFE will be a larger meeting than NETS buts the TOFE executive committee expected fewer local section members to serve as committee member
- TOFE will need a finance chair, publication, and arrangements chair
